SHOW: Friday, March 15, 2013 at 8:00 a.m. EST with Steve Reid, Houstonia, MO judging the show. The show order will be Polled Rams followed by Horned Rams, Horned Ewes and Polled Ewes.

SALE: Saturday, March 16, 2013 at 9:00 a.m. EST with Gary Saylor of Belle Center, OH and Danny Westlake of Marysville, OH selling the sale. The sale order will be the same as the show order.

ENTRY DEADLINE – JANUARY 15: The deadline for entries will be January 15. **PLEASE BE ON TIME!** Entry fees are \$25 per head payable at time of entry. Faxed or emailed entries will not be cataloged until all entry fees have been received. Entries postmarked after January 15 will be charged a double entry fee of \$50. Sale charges will be 10% of your gross. There will be a 2% surcharge on the gross to the Ohio Dorset Assn., one half of which will support their Junior Assn. scholarship fund and activities. One half of one percent will be deducted for the Ohio Sheep & Wool Program. Entry fees will not be refunded on any sheep that are sifted or otherwise fail to make the sale. Please use the enclosed entry form. Provide only the information the form calls for. You DO NOT need to include Assn. numbers on the grand sire and grand dam. Sale Management reserves the right to edit or reduce the size of extremely long footnotes. Use this space wisely and please try to not repeat the same things over and over. Substitutions will be allowed in or out of class, but must be kept within the same sex. Information Sale Day will be accepted. However, it is highly recommended that you include pedigree information on all entries.

CLASSES: For both Polled and Horned Dorsets

Fall Yearling Rams & Ewes (born 9-1-11 thru 12-31-11)

Spring Yearling Rams & Ewes (born 1-1-12 thru 8-31-12)

Early Fall Ram & Ewe Lambs (born 9-1-12 thru 9-30-12)

Late Fall Ram & Ewe Lambs (born 10-1-12 thru 11-30-12)

SLICK SHORN CLASSES FOR 2013:

Slick Shorn Fall Ram Lambs – One class (No Early/Late split)

Slick Shorn Yearling Ewes – One class (No Fall/Spring split)

Slick Shorn Fall Ewe Lambs – One class (No Early/Late split)

Note: Large classes will be split on a round robin basis at Check In time for show purposes only. They will be merged back together for sale order. Also, the judge will place approx. the top 50% of each class with the remainder being randomly drawn for sale order.

CATALOG: A catalog will be printed and mailed to prospective buyers throughout the United States and Canada. Catalogs should arrive around the end of February.

SCRAPIE IDENTIFICATION: ALL entries in the 2013 Ohio Dorset Sale must carry Scrapie identification. Your flock should be enrolled in the Voluntary Scrapie Flock Certification Program OR your entries must be identified with the National mandatory tags. Contact your Vet for information and details.

REGISTRATION PAPERS: All animals must have a valid registration paper. We WILL NOT accept applications for registry. All registration papers are to be turned in at sale check in. These registration papers will be transferred and forwarded to the buyers. Cost of transfers will be deducted from consignor settlements.

HEALTH PAPERS: You must have an individual currently valid health paper for each animal you sell. A copy of the original will be fine for multiple entries and we will need two copies for each entry. A federal scrapie ID must be in each animal's ear. The following information must be legibly written or typed on all health papers: 1) Owner or Consignor name and address. 2) Species and purpose of movement. 3) Private flock tag number. 4) Federal scrapie ID number (Must include premise ID and individual tag number. 5) Age, sex and breed of each animal. 6) The following statement must be recorded on the certificate by the issuing veterinarian: "Sheep in this shipment are not known to be under any movement restrictions due to scrapie." 7) Signature and printed name, address and phone number of accredited veterinarian. As a consignor, please take the responsibility to insure that all of the above information is complete and legible. It is your responsibility to provide sale management clear and legible copies.

ELIZA TESTING: We are not requiring a negative brucellosis test for yearling rams this year. This is optional for you. Here is a list of states that require the blood test for rams to enter the state: Arizona, California, Colorado, Montana, Nevada, North Dakota, Texas, Utah and Wyoming.

DNA TEST RESULTS: Sale Management believes that DNA test results can be a useful tool for both consignors and prospective buyers. We suggest that all consignors post DNA results on stall cards at the pens so that this information can be made available to prospective buyers. This information may be announced from the auction block. Neither Sale Management nor sale sponsors shall assume any liability, legal or otherwise, expressed or implied as it relates to this information.

SALE GUARANTEE: Entry of animals in this sale implies that the consignor agrees to conditions as set forth for this sale. The selling of any sheep through this sale constitutes a contract between the buyer and the seller. All consignors agree that all sheep are guaranteed breeders. All lambs sold must maintain their lamb teeth 12 months from their date of birth, as recorded on their registration paper.

SPECIAL SALE RULES:

CONSIGNMENT: A maximum of fifteen head can be entered by one consignor. Also, a consignor may enter one ram and no ewes, but for each additional ram, two ewes must be consigned. Therefore, if a consignor wants to enter two rams, then they must enter two ewes; three rams, four ewes; four rams, six ewes; etc.

FLEECE LENGTH: The Sale Management and the Ohio Dorset Assn. strongly recommend that all sheep be shown and sold in NO MORE than 1 inch of fleece. This will benefit both buyer and seller.

MINIMUM BID: There will be a minimum bid of \$300 on all yearlings and \$250 on all lambs. Any sheep failing to bring the minimum will be passed through the sale ring with no additional percentages charged.

BEDDING: Fairgrounds Management has requested that straw or shavings only be used for bedding due to difficulty in disposing of other types of bedding.

DV AUCTION: We are once again planning to have the sale webcast with live online bidding via DV Auction.

ARRIVAL TIME: The buildings at the fairgrounds will be ready for arrival on Tuesday, March 12. Anyone wishing to come in prior to that should contact Sale Management.

BEST CONSIGNMENT AWARD: Townsend Sales Livestock Equipment will once again sponsor a Best Consignment Award at this year's Ohio Dorset Show & Sale.

No commission will be charged on sheep that are not yet paid for, thus, we do not get paid until you get paid. Settlement checks are normally mailed 30 days following the sale.

We assume all costs normally related to the sale including barn rent, judging fees, auctioneer fees, all advertising, veterinarian fees incurred for the purpose of reissuing health papers to new buyers, and a complete catalog as well as other incidental costs that normally go with a well managed sale.
